

1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- > Provide a framework in which sensitive discussions can take place.
- > Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene.
- > Help pupils develop feelings of self-respect, confidence and empathy.
- > Create a positive culture around issues of sexuality and relationships.
- > Teach pupils the correct vocabulary to describe themselves and their bodies.

2. Statutory requirements

As a school we provide relationships education to all pupils as per section 34 of the <u>Children and Social work</u> act 2017.

We do not have to follow the National Curriculum but we do offer all pupils a curriculum that is similar to the National Curriculum including requirements to teach science which would include the elements of sex education contained in the science curriculum.

3. Policy development

The consultation and policy development process involved is

1. Staff consultation – all school staff were given the opportunity to look at the policy and make recommendations.

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

Primary sex education will focus on:

- > Preparing boys and girls for the changes that adolescence brings.
- > How a baby is conceived and born.

6. Delivery of RSE

RSE is taught within the personal, social, health and economic education (PSHEE) curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE).

Secondary students also receive stand-alone sex education sessions delivered by a trained health professional. We use Brook Advisory who come into school to deliver these sessions.

Our Primary students

Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- > Families and people who care for me.
- > Caring friendships.
- > Respectful relationships.
- > Online relationships.
- > Being safe.

Our Secondary students

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- > Respectful relationships, including friendships.
- > Online and media.
- > Being safe.
- > Intimate and sexual relationships, including sexual health.

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBTQ+ parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

7. Roles and responsibilities

7.1 The Management Team

The management team will approve the RSE policy.

7.2 Staff

Staff are responsible for:

- > Delivering RSE in a sensitive way.
- > Modelling positive attitudes to RSE.
- > Monitoring progress.
- > Responding to the needs of individual pupils.
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-science components of RSE.

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the principal.

7.3 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

8. Parents' right to withdraw

Primary students

Parents have the right to withdraw their children from the non-science components of sex education within RSE.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Principal.

Alternative work will be given to pupils who are withdrawn from sex education.

Secondary students

Parents have the right to withdraw their children from the non-science components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Principal.

A copy of withdrawal requests will be placed in the student's educational record. The Principal will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

9. Monitoring arrangements

The delivery of RSE is monitored by Joy Parker through planning checks of students work and learning walks, etc.

Students' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the management team every year. At every review, the policy will be approved by the team.

| | How to get further advice, including how and where to access confidential sexual and reproductive health advice and treatment |
